Under the project title 'Strengthening human rights and access to information in the Gaza Strip', ONL will be providing technical back stopping support to its Gaza based partner Palestinian Center for Human Rights (PCHR). This project is funded by the European Commission and co-funded by ONL. Our technical support focuses on two key streams of work under this project, helping PCHR to institutionalize a monitoring and evaluation system in the organisation so that it can show the results of its activities and use them to design better programs. This will be made possible by constant contacts with the local people who are targeted by PCHR in this project who would provide a feedback on what works and what does not work for them when it comes to legal aid and support. The second key piece of work will be helping PCHR to develop a gender sensitive media and advocacy strategy allowing them to create clear messages and use the most appropriate media channels to communicate their messages. The aim will be to help PCHR inform national and international discussions and policy actions with regards to the Israel-Palestine conflict and promote internal accountability. ONL will also facilitate the lobby visits of PCHR to the EU and EU member states.

Actor: Oxfam Novib

Oxfam Novib has been active in the Occupied Palestinian Territory/Israel (OPT/I) since 1982 and working with Palestinian refugees in Lebanon since the mid 1980s. It has built up a strong network of relationships with local NGOs and counts among its local counterparts some of the largest and most professional NGOs in various sectors. It has accompanied these NGOs in their development from ad hoc volunteer groups to sizeable professional institutions with national outreach. At the same time the conceptualisation of the programme has evolved from three country programs in the early 1990s to a program for Palestinians in the Middle East (PME) working with Palestinians in OPT, Israel and Lebanon.

The programme has changed over the years with the establishment of the Palestinian Authority (PA) in the mid-1990s from a focus on support and service provision at a grassroots level and grassroots mobilization, to working towards influencing the establishment of the PA, its lawmaking and supporting building a democratic state # this involved supporting efforts of Palestinian civil society to build the basis for a democratic Palestinian state with room for civil participation, ensuring inclusion of vulnerable groups, refugees and women, and shaping its laws and systems. Oxfam Novib has also supported partners that are working on the provision of humanitarian assistance, response preparedness and conflict transformation. We have also supported partners in the provision of health services, access to quality education and gender justice.
